Commercial/Industrial Lighting Rebate Program

APPLICATION PROVISIONS:

Deadlines and Eligible Customers

Items must be purchased between January 1 and December 31 of each calendar year. Rebate application for these items must be filed by March 1 of the following calendar year.

Only commercial and industrial customers of State Center Municipal Utilities are eligible for the existing Lighting Program. All lights receiving rebates from the program must be installed in facilities that are located in the State Center Municipal Utilities service territory.

*Fixture or bulbs must be listed as Energy Star qualified at time of purchase. More Info on ENERGY STAR found at www.energystar.gov. Attach EnergyStar verification.

*Design Lights Consortium (DSL) Qualification. Search <https://www.designlights.org/> for product list of specific model numbers and provide printed verification.

No customer shall receive more than 3 lighting rebates or \$2,000 worth of rebates from State Center Municipal Utilities during any period of 12 consecutive months.

Note: State Center Municipal Utilities has a fixed amount of funds committed to lighting rebates annually. Applications will be processed as they are received, on a first come, first serve basis until all funds have been appropriated for that year.
