## State Center City Council Regular Meeting Minutes November 16, 2021

State Center City Council met in regular session on Tuesday, November 16, 2021, at the City Hall Council Chambers. Mayor Protem Wilkinson called the meeting to order at 6:30 p.m. All rose for the Pledge of Allegiance. Present were Councilors Darrow, Nichols, Quick, and Shaffar. Absent: Mayor Sodders. Also present: L. Bearden, K. Yates, K. O'Hare, Z. Faught, J. Robinson, B. Pfantz, K. Nieland, Bob Grant, Craig Pfantz and Chris Davis.

Motion by Darrow, 2<sup>nd</sup> by Nichols that the consent agenda including Res. 22-32 Monthly Transfers in total amount of \$162,277.70. Yates made note that the John Deere Financial check will be reissued for the correct amount of \$184.18. Motion passes 5-0 roll call

Bearden administered the Oath of Office to the election winners. Craig Pfantz as four-year term mayor, Terry Shaffar, Brett Nichols, and Bob Grant as 4-year term council persons and Harlan Quick filling the remaining two years of a previously vacated four-year term. Quick's partial term begins immediately while the other terms all begin the first of the year.

Motion by Shaffar, 2<sup>nd</sup> by Nichols that Ordinance 363 amending be given its second reading for passage. Motion passes 5-0.

Motion by Darrow, 2<sup>nd</sup> by Nichols that Res. 22-33 for the annual appropriation of TIF funds for reimbursement to SCDA for FY23 grocery store property taxes be adopted. Res. 22-33 is adopted 5-0 roll call.

Motion by Quick, 2<sup>nd</sup> by Darrow that Res. 22-34 approving the FY21 annual urban renewal report. Res. 22-34 is adopted 5-0 roll call.

The current and new council/mayors will meet Dec. 14th at 6:30 p.m. for a financial/budget work session.

Bearden read a thank you note from NuBeta for the city's assistance in redoing the city sign landscaping.

Motion by Shaffar, 2<sup>nd</sup> by Quick to add the annual emergency water agreement with the Iowa Veterans Home in Marshalltown. Motion passes 5-0. Motion by Quick, 2<sup>nd</sup> by Darrow to approve the annual agreement with the Veterans Home. Motion passes 5-0 roll call.

Motion by Shaffar, 2<sup>nd</sup> by Nichols to approve the addition of Teresa Struchen to the Fire.EMS roster. Motion passes 5-0.

Civil penalties were not discussed. Discussion between O'Hare and Thomas determined that present ordinance is sufficient.

Kohle Nieland of CGA shared that while seeding is complete 70% establishment could not be confirmed. He will continue SWPP test. He recommended payment of the new Soiltek invoice in amount of \$8,200.00. This is more than the previously approved amount of \$6,000.00 due a larger area needing to be seeded. Motion by Quick, 2<sup>nd</sup> by Darrow to adopt Res. 22-37 approving the new

amount to Soiltek in amount of \$8,200.00 and voiding previously approved amount of \$6,000.00. Some overseeding may need to be done in the spring but may be able to be done in house or with local contractor. Res. 22-37 is adopted 5-0 roll call.

Motion by Shaffar, 2<sup>nd</sup> by Nichols to adopt Res. 22-35 approving payment of Pay Application #4 in amount of \$37,094.18 to Con-Struct for work on E Main/2<sup>nd</sup> St HMA project. Res. 22-35 is adopted 5-0 roll call.

Motion by Shaffer, 2<sup>nd</sup> by Darrow to adopt Res. 22-36 approving payment of Pay Application #3 in amount of \$13,592.13 to InRoads for work on 4<sup>th</sup> St HMA project. Res. 22-36 is adopted 5-0 roll call.

A special meeting is set for Tuesday, Nov. 23, 6:30 p.m. for the purpose of hiring a public works employee after interviews this week.

Robinson gave a brief update on upgrade progress and the short outage this week.

There being no further business, motion by Shaffar, 2<sup>nd</sup> by Nichols to adjourn, motion passes 5-0.
