State Center City Council Regular Meeting Minutes October 18, 2022

Mayor Pfantz opened the meeting at 6:30 p.m. Present were Mayor Pfantz, Councilors Darrow, Grant, Nichols, Shaffar and Quick. Absent: None. Also present were L. Bearden, K. Yates, J. Thomas, Z. Faught, J. Robinson, C. Davis, Kohle Nieland, Brad Pfantz, Nick Frederiksen of ISG, representatives of Mediacom and Linda Wells.

- Motion by Quick, 2nd by Darrow to approve the consent agenda which included a liquor license for Hometown Foods and Res. 23-18 monthly transfer resolution totaling \$37,997.98. The consent agenda is approved 5-0 roll call.
- Representatives of Mediacom answered further questions regarding the installation of Mediacom fiberoptics in the city rights-of-way. They stated it would take near 6 months to complete the installation that will run fiber everywhere necessary to give any property possible access to Mediacom service. The city's concerns that Mediacom work with our electric and public works departments when ordering locates, and repair of any damage done by Mediacom during installation. Being satisfied that Mediacom will work with the city, Shaffar moved to approve Mediacom to proceed with the installation of fiber in the city right-or-way. Nichols 2nd; motion passes 4-0 with Quick abstaining due to his relationship with Partner Communications.
- Robinson updated recent electric department progress.
- There was brief discussion regarding possible brush dump location. There is no new progress.
- Darrow moved to adopt Res. 23-20 approving of Pay App #4 to InRoads in amount of \$970.00 for the 4th St. Project. Grant 2nd; Res. 23-20 is adopted 5-0 roll call.
- Motion by Grant, 2nd by Darrow to adopt Res. 23-21 approving the FY22 Annual Finance Report. It is scheduled to be published 10.20.23 Res. 23-16 is adopted 5-0 roll call.
- The clerk reviewed a new monthly utility reconciliation report that will be included in the consent agenda.
- The clerk reported that FY23 budget amendment #1 is being prepared for review at the November meeting.
- Quick moved to adopt Res. 23-22 setting a public hearing for 11.15.22 to hear comments regarding proposed rezoning of two separately located properties from residential to commercial. Grant 2nd; motion passes 5-0 roll call.
- The public right-of-way vacation on the south 300 block of 3rd St NW is tabled until the property can be surveyed for a legal description.
- After brief discussion, the clerk will schedule meetings with two prospective city attorney candidates.
- Chief Thomas updated council on progress with nuisance properties.
- At 7:15, there being no further business, motion by Grant, 2nd by Shaffar to adjourn; motion passes 5-0.
